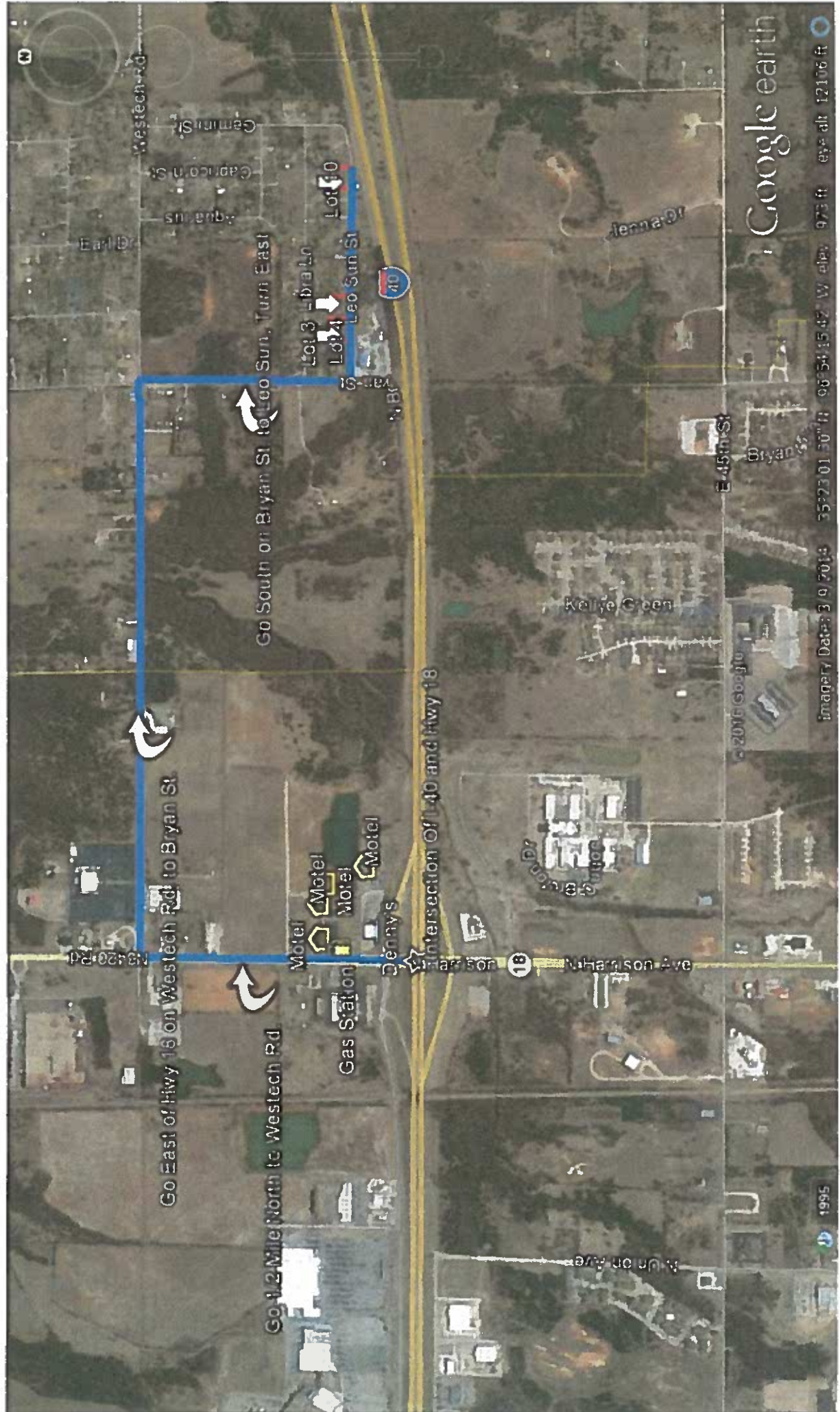

Go 1.2 Mile North to Westech Rd

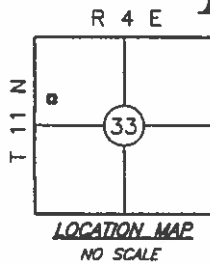
Go South on Bryan St to Leo Sun, Turn East

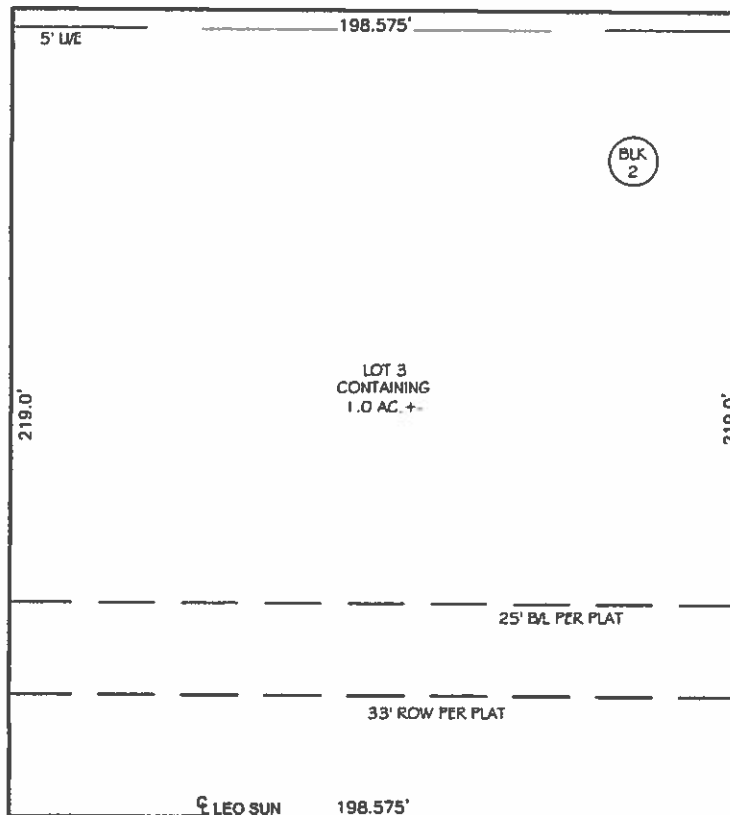
